The Buyer further promises to pay (1) a delinquency charge for default in payment in each and any installment if default continues for a period of 15 days, such charge to be 5% of the unpaid amount of such installment or \$5.00, (in Colorado, \$5.00; Kansas, \$2.50; Utah and Idaho, \$6.00), whichever is lower, or at the option of the Seller, a default charge on said defaulted installment or installments at the rate shown as the Annual Percentage Rate expressed in this contract for such period of default as may be granted and (2) where permitted by law, all expenses including court costs and reasonable attorney's fees if the goods are taken by the Seller or the Seller's assigns and sold again or if this agreement is placed with an attorney for collection after maturity.

The Seller retains title to the goods and a security interest therein and in all replacements and additions thereto, under the Uniform Commercial Code, to secure payment and performance of all obligations of the Buyer hereunder.

"ADDITIONAL PROVISIONS" AND "STATEMENT CONCERNING WARRANTIES" ON THE REVERSE SIDE ARE INCORPORATED HEREIN BY REFERENCE.
