M. Berge and L. A. Berge all interest in the following described real-estate, namely:

Beginning at a point fifteen (15) feet East of the North West corner of the South East Quarter of Section twenty three (23), Township three (3), North of Range eight (8), East of the Willamette Meridian, running thence South one hundred (100) feet; thence East one hundred forty-five (145) feet; thence North one hundred (100) feet; thence West one hundred forty-five (145) feet to the place of beginning.
