EASEMENT DEED

THE GRANTOR, Skamania County, Washington of Skamania County, Washington for and in consideration of One and no/100ths (\$1.00) DOLLARS, in hand paid, conveys to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, an easement or right-of-way for an electric transmission and distributing line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and including the right to place all said lines in underground conduits) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described premises, located in Skamania County, Washington to-wit:

The South Half (S $\frac{1}{2}$) of the northeast quarter (NE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section twenty-one (21), township three (3) North, Range ten (10) East Willamette Meridian.

Said power line to be constructed along the southerly line of the above described lands and parallel to the north line of the county road extending along the southerly line of said lands.

Together with the right of ingress and egress over the adjacent lands of the Grantor for the purpose of constructing, reconstructing stringing new wires on, maintaining and removing said lines and appurtenances, and exercising other rights hereby granted.

All rights hereunder shall cease when said lines have been abandoned.
