Quit Claim Deed

The Grantors, Lee M. Miller and Della B. Miller, husband and wife now and at all times since the said Lee M. Miller acquired the within described property, for and in consideration of the sum of ten dollars (\$10.00) in hand paid, and other good and valuable consideration, CONVEY and QUIT CLAIM to W. J. Ewing, Jr. and Mildred Stoller Ewing, husband and wife, all interest in the following described real estate, situate in the County of Skamania, State of Washington:

Beginning at the Northwest corner of the Southwest quarter of Section 30 in Township 2 North, Range 6 East of the Willamette Meridian; running thence East along the half section line 53 rods to a point; thence South, parallel with the West line of said Section, 80 rods; thence West 53 rods to a point in the West line of said Section 30; thence North along said West line 80 rods to the place of beginning, containing 26½ acres.

Also: Beginning at the Northeast corner of the Southwest quarter of Section 30, Township 2 North of Range 6, East of the Willamette Meridian; thence South 106 rods; thence West 80 rods; thence North 26 rods; thence West 27 rods; thence North 80 rods; thence East 107 rods to the point of beginning, containing 66½ acres, more or less.

Also: The Northeast quarter of the Southeast quarter of Section 25 in Township 2 North of Range 5 East of the Willamette Meridian.

Excepting, however, a strip of land 300 feet in width across all of the above described tracts of land, as surveyed, laid out and appropriated by the Bonneville Project of the United States of America, said strip of land containing 16 acres, more or less.
