Quit-Claim Deed.

The Grantors, Amadee St. Martin and Marie St. Martin, husband and wife, in consideration of the sum of One Dollar and other consideration in hand paid, receipt whereof is hereby acknowledged, do by these presents CONVEY and QUITCLAIM unto May St. Martin, grantee, all of their right, title and interest in and to the following described real property situated in Skamania County, Washington, to-wit:

The West $\frac{1}{2}$ of the Southwest $\frac{1}{4}$ and the Northeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ in Section 22, Township 3 North Range 8 E.W.M.

Also that part of Lot 2 North of Wind River, less $9\frac{1}{2}$ acres sold to the United States Government for a power line right of way in Section 27, Township 3 North, Range 8 E. W. M.; together with all right, title and interest in and to that certain easement granted by the United States Government Bonneville Authority to the grantors herein.

Also the Southeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$, and the Northeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ in Section 21, Township 3 North, Range 8 E. W. M.

Also the East $\frac{1}{2}$ of the Southwest $\frac{1}{4}$, and the South $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ of Section 21, Township 3 North, Range 8 E. W. M.

Also the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$; the South $\frac{1}{2}$ of the Southeast $\frac{1}{4}$; the Northeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 22, Township 3 North, Range 8 E. W. M.

Also 20 acres in Section 20, Township 3 North, Range 8 E. W. M. commencing at the Northeast corner of the Northwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$, thence South 122 rods for a point of beginning; thence South 80 rods, West 80 rods, North 40 rods, thence East 80 rods to said point of beginning.

It is the intention of the grantors herein to convey unto the grantee all of their right, title and interest in and to any and all real estate now owned by the grantors in Skamania County, Washington, whether the same is included in this description or not.
