Skamania Co. by Commissioners to State Forest Board

D E E D

This indenture made and entered unto in triplicate this 7 day of April, 1941, by and between Skamania County, Washington, grantor, and the State Forest Board of the State of Washington, grantee, WITNESSETH, that

WHEREAS, Skamania County, Washington, heretofore acquired title to the herein conveyed tracts, parcels, lots or lands upon the foreclosure of tax liens thereon and by other means, and

WHEREAS, on the 7th day of April, 1941, the State Forest Board selected and designated said lands hereinafter described as state forest lands, and requested that said lands be conveyed by said Skamania County by good and sufficient deed to the said State Forest Board of the State of Washington under Chapter 154, Laws of 1923, and acts amendatory thereof and supplemental thereto, and Chapter 126, Laws of 1935, and

WHEREAS, the county commissioners of Skamania County have, by resolution, duly made and entered on this 7 day of April, 1941, authorized the transfer of said lands to the State Forest Board;

NOW, THEREFORE, because of said demand by said State Forest Board and said resolution of the county commissioners of Skamania County, and in compliance therewith and by authority of the above-cited statutes of the State of Washington, and in consideration of the sum of One Dollar (\$1.00) paid to the grantor by the grantee, receipt whereof is hereby acknowledged, the grantor has granted, bargained, sold and conveyed, and by these presents does bargain, grant, sell and convey to the State Forest Board of the State of Washington, those certain tracts and parcels of land lying and being in Skamania County, Washington, and more particularly described as follows, to-wit:
