

Beginning at survey station 222+73.68, a point on the survey line of the North Bonneville-Vancouver transmission line No. 3 in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 23, Township 2 North, Range 6 East of the Willamette Meridian, said point being 624.39 feet south and 1169.23 feet east of the quarter section corner on the west line of said Section 23; thence N. 12 degrees 13 minutes E. 115.6 feet; thence N. 8 degrees 09 minutes E. 135.5 feet; thence N. 43 degrees 43 minutes E. 128.0 feet; thence N. 8 degrees 30 minutes E. 123.1 feet; thence N. 51 degrees 01 minute E. 106.2 feet to the center of the Kuffler County Road No. 84 in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of said Section 23, said point being 96.35 feet south and 1402.05 feet east of the quarter section corner on the west line of said Section 23.

Beginning at survey station 233+64.98, a point on the survey line of the North Bonneville-Vancouver transmission line No. 3 in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 23, Township 2 North, Range 6 East of the Willamette Meridian, said point being 166.91 feet south and 178.38 feet east of the quarter section corner on the west line of said Section 23; thence N. 67 degrees 10 minutes E. 209.9 feet; thence N. 79 degrees 22 minutes E. 203.8 feet; thence S. 88 degrees 23 minutes E. 142.7 feet; thence N. 89 degrees 47 minutes E. 246.5 feet; thence S. 88 degrees 07 minutes E. 145.0 feet; thence S. 82 degrees 10 minutes E. 298.7 feet to the center of the Kuffler County Road No. 84 in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of said Section 23, said point being 96.35 feet south and 1402.05 feet east of the quarter section corner on the west line of said section 23.

4. That possession of all such property that is now vacant, unoccupied and uncultivated be given to the United States to the extent of its rights under the perpetual easements and rights-of-way hereinbefore described immediately. That as to the part of such property that is now occupied or cultivated, possession be given to the United States to the extent of its perpetual easements and rights-of-way as aforesaid, on the 26 day of February, 1943.

5. That the return date in the above entitled cause is hereby fixed for the 15th day of April, 1943, at 10 A. M.
