WARRANTY DEED

(Deed from Lavella M. Brumitt From Glen E. Brumitt July 12, 1943)

THE GRANTORS, Emil Cretegnny and Alice Cretegnny, husband and wife, for and in consideration of the sum of ten dollars to them in hand paid by Glenn Brummit, the receipt whereof wich is hereby acknowledged, CONVEY AND WARRANT to the said Glenn Brummit the following described real property situate in Skamania County, State of Washington to-wit:

Begining at a point 16½ feet South and 198 feet East of the Northwest corner of the SE¼ of the NE¼ of Sec. 29 Twp. 3 N.R. 8 E.W.M. (or the East line of the Carson Depot Road) running thence East to Carson Creek, thence in a Southwesterly direction along said Carson creek to a point 256½ feet South of the North line of the SE¼ of the NE¼ of Sec. 29 thence West to the East line of Carson Depot Road, thence in a Northeasterly direction along the East line of said Carson Depot road to the point of begining; being a parcel of land 240 feet in width North and South between the Carson Depot Road and Carson creek and lying 16½ feet South of the North line of the SE¼ of NE¼ of Sec. 29 Twp. 3 N.R. 8 E.W.M.

TO HAVE AND TO HOLD the said premises unto the said Glenn Brummit and to his heirs and assigns forever, subject however to a right ao way heretofore granted by Grantees to the Public Utility District No. one of Skamania County, for the purpose of constructing an electric transmission line over and across said premises.
