## CORRECTION WARRANTY DEED

THE GRANTORS, LESTER A. BURNS and BLANCHE I. BURNS, husband and wife, now and at all times since acquiring the within described property, for and in consideration of the sum of Ten dollars (\$10.00) in hand paid, and other good and valuable consideration, convey and warrant to YVONNE JACKSON, a single woman, the following described real estate situate in the County of Skamania, State of Washington:

Starting at the Northwest quarter corner of the Northeast quarter of Section 32, Township 2 North, Range 5 East of the Willamette Meridian; thence South 1660 feet to the center of the present County Road known as the Burns Road; thence Easterly along center of said road to a point which is 770 feet due East from said West line and 1290 feet South of the North line of said Section 32; thence Northeasterly following the center of said County Road to the North line of Section 32; thence West on said section line approximately 1320 feet to the true point of beginning. The land herein conveyed is all of that land which lies North and West of the center of said road and lying within the Northeast quarter of said Section 32 and containing 35 acres, more or less.
