

WATER PIPE LINE EASEMENT

The grantors, CHARLES M. ROBERTS and FLORENCE M. ROBERTS, husband and wife, of Carson, in the County of Skamania, State of Washington, for and in consideration of Ten Dollars and other valuable considerations in hand paid, grant, bargain, sell and convey to SKAMANIA COUNTY PUBLIC UTILITY DISTRICT NO. 1, a municipal corporation of the State of Washington, its successors and assigns, an easement for a water pipe line 20 feet in width being 10 feet in width on either side of the center of the pipe line as presently located, installed and in use on the following described real property located in Skamania County, State of Washington:

Government Lot 3 of Section 8; and the northeast quarter of the northwest quarter of Section 17, Township 3 North, Range 8 E. W. M.; and as more particularly deentified by the drawing attached hereto and by reference incorporated herein.

It is agreed that the foregoing described easement shall include the right to construct a footpath for the purpose of access to the said pipe line to be used in maintaining and repairing the same; that the said easement shall include the right to construct, repair and maintain concrete footings and a bridge for the said pipe line over Wind River; and that the said easement shall include the right to cut such brush and trees in the said right of way as may be reasonably necessary in the repair and maintenance of the same and to cut such danger trees on the above described real property as reasonably may be required in order to protect the said pipe line and bridge over Wind River against damage from falling timber.

But it is further specifically agreed that the aforesaid easement shall not include the right to construct on the above described real property any road or other means of access to the said pipe line for the use of any vehicle, and by the acceptance of these presents the grantee covenants to and with the grantors that it will not construct or cause to be constructed on the above described real property any road or way for the use of vehicles; and the grantors hereby reserve the right to construct fences along the legal boundaries of the above described real property.
