Statutory Warranty Deed

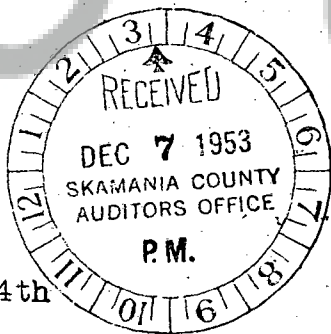
THE GRANTOR EMMETT C. WHITE, a single man
