

SKAALHEIM, his wife, for and in consideration of Ten Dollars and other Valuable Considerations, in hand paid, conveys and warrants to AVARY SKAALHEIM, a single man, the following described real estate, situated in the County of Skamania, State of Washington:

All right, title and interest, consisting of an undivided one-half interest, in the following described real property:

Beginning at a point on the east boundary line of the Southwest Quarter of Section 26, Township 9 North, Range 8 E. W. M., which said point is south 0° 11' east 1390 feet from the northeast corner of said Southwest Quarter of said Section 26; thence south 50° 49' west 63.2 feet; thence south 38° 28' west 123.3 feet; thence south 22° 46' east 177 feet; thence south 34° 47' west 225.3 feet; thence north 3° 52' west 192.5 feet; thence north 69° 40' west 90.6 feet; thence south 72° 40' west 212.2 feet; thence south 1° 23' east 231.6 feet; thence south 36° 32' west 137.1 feet to a point on the north boundary line of that certain 15.23 acre tract now owned by EDWARD C.
