COMMUNITY PROPERTY AGREEMENT

THIS AGREEMENT, made and entered into by and between HARRY R. TRUMAN and EDNA O. TRUMAN, husband and wife, residing at Spirit Lake in Skamania County, State of Washington, and whose mailing address is P. O. Box 96, Castle Rock, Washington,

WITNESSETH:

WHEREAS, the said HARRY R. TRUMAN and EDNA O. TRUMAN, husband and wife, are the owners of certain real and personal property in Skamania County, State of Washington; and,

WHEREAS, the parties hereto are desirous that their property, whether real, personal or mixed, and of any nature whatsoever, shall pass without delay or expense in the event of the death of either of them to the survivor thereof, in the manner provided by law;

NOW, THEREFORE, in consideration of the love and affection that each of said parties bears for the other and the mutual covenants herein contained, IT IS HEREBY AGREED that all of the property owned by them, or either of them, whether real, personal or mixed, and of every nature whatsoever, is the community property of the parties hereto, and it is hereby DECLARED that all of said property is the community property of the parties hereto, and that all property hereafter acquired by the parties hereto, or either of them, whether real, personal or mixed, and of every nature whatsoever, shall be the community property of said parties, and the same is hereby DECLARED to be the community property of said parties.

IT IS FURTHER AGREED by the parties hereto that in case of the death of the said HARRY R. TRUMAN while the said EDNA O. TRUMAN him survives, the whole of said property hereinabove mentioned, together with any other property owned by them at that time, shall at once vest in the said EDNA O. TRUMAN, in fee

simple, as her sole and separate estate; and in the event of the death of the said EDNA O. TRUMAN, leaving the said HARRY R. TRUMAN her surviving, then and in that event the whole of said property hereinabove mentioned, together with all property owned by them at that time, shall at once vest in the said HARRY R. TRUMAN, in fee simple, as his sole and separate estate; and this agreement shall be deemed a separate conveyance from the party first departing this life to such surviving party, without probating said estate, but in the manner provided by the laws of the State of Washington.

IT IS MUTUALLY UNDERSTOOD AND AGREED that the survivor of the parties hereto may elect to waive rights of survivorship under this agreement and submit to the jurisdiction of probate proceedings in the Superior Court of the State of Washington.
