



A tract of land located in the Northeast Quarter of the Northeast Quarter (NE<sub>4</sub>, NE<sub>4</sub>) of Section 20, Township 3 North, Range 3 E. V. M., described as follows:

Beginning at a point 65 rods south of the northeast corner of the said Section 20; thence west 18.5 rods; thence north 13 rods; thence east 18.5 rods; thence south 13 rods to the point of beginning; said tract containing 1.5 acres, more or less.
