

QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, that CROWN ZELLERBACH CORPORATION, a Nevada corporation, in consideration of One Dollar (\$1.00) to it paid by the STATE OF WASHINGTON, does hereby remise, release and forever QUITCLAIM unto the said STATE OF WASHINGTON, its successors and assigns, for radio communication purposes, all of its right, title and interest in and to the following described property, to-wit:

A tract of land lying in the Southeast one quarter of Section 4, T2N, R6E, W.N., Skamania County, Washington, more particularly described as follows:

Commencing at the Southeast corner of said Section 4; thence North 59° 51' 45" West 1287.45 feet to the true point of beginning; thence North 52° 52' 20" West 300.00 feet; thence North 37° 07' 40" East 300.00 feet; thence South 52° 52' 20" East 300.00 feet; thence South 37° 07' 40" West 300.00 feet to the point of beginning and terminus of this description.

SUBJECT TO: An easement for an existing 20 foot wide access road over and across the above described tract, the centerline of said road being more particularly described as follows:


Beginning at a point on the southeasterly line of the above described tract, said point being South 37° 07' 40" West 77.67 feet when measured along said line from the most Easterly corner of said tract; thence leaving said line North 50° 50' 15" West 128.87 feet; thence North 25° 01' 35" West 74.24 feet; thence North 43° 59' 50" West 106.93 feet to a point on the Northwesterly line of said tract and terminus of this description, said point of terminus being South 37° 07' 40" West 20.06 feet when measured along said line from the most Northerly corner of said tract.


Containing 2.07 acres, more or less.

TO HAVE AND TO HOLD SAID real property unto the said STATE OF WASHINGTON, its successors and assigns forever, for radio communication purposes. Provided, however, and CROWN ZELLERBACH CORPORATION hereby quitclaims, releases and relinquishes its interest in said property upon the express condition that such property shall be used for a microwave/VHF radio state site only and that in the event the State of Washington, its successors and assigns, shall cease to use said property and/or abandons the use of such property for such purposes, then the title thereto shall revert to and re-vest in Crown Zellerbach Corporation, its successors and assigns, without any further act on its part.
