it is agreed between the parties that if the timber is cut between the 1st day of April, and the 15th day of September, of the year, the Purchaser shall provide fire trails around each unit prior to cutting, and whereas

all cutting, logging and clean up operations must be completed before the 15th day of October, 1980, and whereas

the main road traversing subject property, must be kept clear and in adequate repair to enable automobile travel at all times, and upon completion of logging operation, the road is to be cleaned up, smoothed, and backbladed by the purchaser, and whereas,

Purchaser agrees to conduct all logging operations in compliance with the regulations set out by the Department of Natural Resources and any other governing body having jurisdiction over timber removal in the State of Washington, and whereas,

Purchaser agrees to assume the burden of any and all taxes that may be levied against subject timber value or cutting from the 1st day of January, 1978 or until Contract completion, and whereas,

Purchaser agrees to windrow and or burn in a manner suitable for planting that will satisfy the rules set out by the Forest Practices Act. In addition Purchaser agrees to put the land in compliance with the Forest Practices Act as the timber shall be removed, and whereas,

Purchaser agrees to remove the timber from subject property in a workmanship like manner and to indemnify the land owners against any damages, lawsuits, or actions against the land owner from acts that are caused by Purchaser's logging operation.
