

WARRANTY DEED

THE GRANTORS, ELWIN C. DEXTER and RUTH E. DEXTER, husband and wife, for and in consideration of the sum of ONE HUNDRED TWENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$125,000.00), the receipt whereof is hereby acknowledged, do hereby convey and warrant unto ERNEST R. RAND and ENID D. RAND, husband and wife; MATTHEW CALIFF and ELAINE J. CALIFF, husband and wife, and WILLIAM S. UPSON and KIM C. UPSON, husband and wife, the Grantees, the following described real property situated in Skamania County, State of Washington, to-wit:

The North half of the Southeast Quarter (N 1/2 SE 1/4), and the Northeast Quarter (NE 1/4-SW 1/4), of Section 33; and the North half of the Southwest Quarter (N 1/2 - SW 1/4) of Section 34; all in Township 2 North, Range 5 East of the Willamette Meridian,

TOGETHER WITH water rights and water easements appurtenant to said property as now appearing of record, EXCEPT County Roads, and subject to electric transmission line easements as now appearing of record. TOGETHER WITH the four mobile homes now permanently installed on said property which are deemed fixtures as hereinafter provided.
