Except: A tract of land located in the S^{1}_{2} of the NW $^{1}_{4}$ of Section 23, T3N, R8EWM, more particularly described as follows: that portion of the North 350 feet of the South $^{1}_{2}$ of the Northwest $^{1}_{4}$ of Section 23, T3N, R8EWM lying easterly of the Berge Road.

EXCEPT A parcel located in the south half of the northwest quarter of Section 23, Township 3 North, Range 8E.,W.M.

Beginning at the Southeast corner of the South half (S2) of the Northwest Quarter (NW4) of Section 23, Township 3 North, Range 8 E.W.M.; thence northerly along the North/South centerline of said Section 23, 283 feet to the true point of beginning of this description; thence continuing northerly along the North/South centerline 208 feet; thence westerly 208 feet along a line parallel with the East/West centerline of said Section 23; thence southerly 208 feet; thence easterly 208 feet to the true point of beginning.
