A tract of land located in the east ten (10) acres of Lot 2 of Oregon Lumber Company's Subdivision in Section 14, Township 3, North, Range 9 E.W.M., according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington, described as follows: Beginning at the Southwest corner of the East ten (10) acres of Lot 2 aforesaid; thence East along the South line thereof 198 feet to the initial point of the tract hereby described; thence East along said South line 100 feet; thence North 150 feet; thence West 100 feet; thence South 150 feet to the point of beginning.

JANE E. GRAZIER died on the 26th day of February, 1979, and ROBERT E. ROGERS was confirmed as Executor of her last will and testament on the 20th day of August, 1979, and ever since has been and is now the duly appointed, qualified and acting Executor thereof.

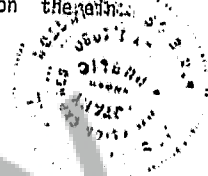
