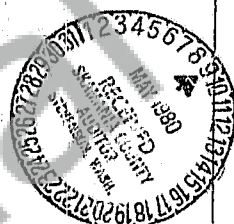

2. Object of Action. To compel arbitration under an agreement to arbitrate by the parties to this action.

3. Title. The action affects the title to the following described real estate situated in Skamania County, State of Washington:
