

QUITCLAIM OF MINERAL RIGHTS


Transferors, in consideration of Two Hundred Dollars (\$200.00) paid to them by transferee, receipt of which is acknowledged, do by this instrument remise, release, and forever quitclaim to transferee, his heirs, and assigns, all rights, title, and interest owned, claimed, or held by transferors in and to the mineral rights and interest in and to that certain real property located in Skamania County, State of Washington, more particularly described as follows:

Beginning at the West quarter corner of Section 2, Township 2 North, Range 7 East of the Willamette Meridian, in the County of Skamania and State of Washington; thence East 350 feet; thence South 66° 48' East 1,066 feet to the true point of beginning of the tract to be described herein; thence North 40° 32' 30" East 648 feet to the Northeast corner of that tract conveyed to Robert M. Talent, et ux, by deed recorded April 30, 1974 in Book 66, page 646 Deed Records; thence South 36° 30' 4" East 122.6 feet; thence South 79° 40' 4" East 97.6 feet; thence North 53° 54' 56" East 365.9 feet more or less to the most Southwesterly corner of that tract described in contract to Willamette Land, Inc., recorded March 30, 1978 in Book 74, page 499 Deed Records; thence Easterly along the South line of said Willamette Land tract to a point which bears North 75° 27' East from a point which is South 66° 48' East 454 feet from the true point of beginning; thence South 35° 27' West to a point which bears South 66° 48' East 454 feet from the true point of beginning; thence North 68° 48' West 454 feet to the true point of beginning.
