of July, 1976, hereby conveys and quitclaims unto THE UNITED STATES OF  
AMERICA, DEPARTMENT OF THE ARMY, CORPS OF ENGINEERS, all its right,  
title and interest, in and to the following described real property  
situated in Skamania County, State of Washington:

That portion of the former right of way of State Highway Route  
No. 14, as said right of way existed prior to July 2, 1976,  
through Sections 14, 15, 19, 20, 21 and 22, Township 2 North,  
Range 7 East, W.M., and extending from Highway Engineer's Station  
150+10.0 on the survey line of SR 14, Beacon Rock to Greenleaf,  
easterly to Highway Engineer's Station 92+55.0 on the survey line  
of SR 14, Rands to Greenleaf.

The specific details concerning all of which may be found on sheet 3 of  
that certain plan entitled SR 14, Beacon Rock to Greenleaf, now of record  
and on file in the office of the Secretary of Transportation at Olympia,  
Washington, bearing date of approval March 16, 1926, and on sheets 3, 4, 5  
and 6 of that certain plan entitled SR 14, Rands to Greenleaf, now of  
record and on file in the office of the Secretary of Transportation at  
Olympia, Washington, bearing date of approval April 24, 1923.

and are conveyed pursuant to the provisions of R.W Chapter 47.12.080.
