RELEASE OF EASEMENT

WHEREAS, ARTHUR H. ARP, a single man, is Grantor of an easement to the UNITED STATES OF AMERICA granting the right to use and maintain an access road over and across the Grantor's land located in the SW1/4 of Section 23, Township 2 North, Range 6 East, Willamette Meridian, Skamania County, Washington, which easement was recorded on May 29, 1980, in Book 78 of Deeds, Page 273, records of Skamania County, Washington; and

WHEREAS, before payment for said easement was made, it was determined that the balance of the access road could not be acquired, and that adequate access could be constructed within the transmission line right-of-way; and

WHEREAS, the respective parties have mutually agreed that all rights of the said parties under said easement shall be terminated and the parties shall be relieved of their obligations under said instrument;

NOW, THEREFORE, the UNITED STATES OF AMERICA, Department of Energy, acting through the Bonneville Power Administrator, pursuant to the Acts of Congress approved August 20, 1937 (50 Stat. 751, 16 U.S.C. 832a et seq.), as amended, and June 30, 1949 (63 Stat. 377, 40 U.S.C. 471 et seq.), as amended, and regulations issued pursuant thereto, does hereby release the SW1/4 of Section 23, Township 2 North, Range 6 East, Willamette Meridian, Skamania County, Washington, from the burden of the easement imposed upon the above-described property by that certain easement deed from ARTHUR H. ARP, a single man, to the UNITED STATES OF AMERICA and recorded on the 29th day of May, 1980, in Book 78 of Deeds, Page 273, records of Skamania County, Washington.
