of the Burlington Northern Railroad lying over and across Section 19, 20 and 21,
Township 2 North, Range 7 East of the Willamette Meridian, Skumania County, State
of Washington, lying easterly of the west line of the S.M. Hamilton D.L.G. No. 40
and northwesterly of existing railroad station 2037+36.83, containing 49.23 acres,
more or less.

TO HAVE AND TO HOLD the same together with all and singular the appur-
tenances, hereunto belonging or in anywise appertaining, and all the estate
right, title, or equity, to the only proper use, benefit and interest of the
said party of the second part, its assigns, forever.

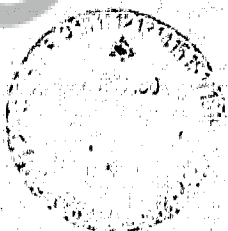
This deed is given pursuant to and as partial performance of Relocation
