EASEMENT DEED

SKALA, husband and wife, for and in consideration of ONE AND NO/100 DOLLARS (\$1.00) in hand paid, receipt of which is hereby acknowledged, have granted, bargained, and sold and by these presents do hereby grant, bargain, sell and convey unto the UNITED STATES OF AMERICA and its assigns a perpetual and assignable easement and right-of-way in, upon, over, under and across that certain parcel of land situate in the County of Skamania, State of Washington, described as follows:

A strip of land situated in Section 20, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington, said strip being 10.00 feet in width lying 5.00 feet wide on each side of a centerline being more particularly described as follows:

Commencing at a point which bears North 89°01'33" East, 2,143.64 feet from the Northeast corner of the E.C. Hardy Donation Land Claim No. 41; thence North 22°28'16" East to the Southerly line of Lot 6, Block 6 of the Plats of Relocated North Bonneville and the POINT OF BEGINNING:

thence continuing North 22°28'16" East to the Northerly line of said Lot 6 and the point of terminus of this description.

The side lines of said strip of land are lengthened or shortened to begin and end on the lot lines of said Lot 6.

The tract herein described contains .03 of an acre, more or less.

The easement and right-of-way hereby conveyed are for the purpose of the construction, operation, maintenance, alteration and repair of a sewer pipeline.
