## COMMUNITY PROPERTY AGREEMENT

This COMMUNITY PROPERTY AGREEMENT entered into this date by and between Ronald C. Aalvik and Nancy M. Aalvik, husband and wife, of Carson in Skamania County, State of Vashington:

## WITNESSETH:

WHEREAS, the parties hereto are the owners of certain real and personal property situate in the State of Washington; and
