WEDEKIND and BESSIE E. WEDEKIND, husband and wire.

In this agreement so made, one with the other, the date acquiring property and all statements made by either or both of us heretofore respecting alleged separate property, or affecting any property, are to be regarded and esteemed as of no force and effect.

The full intent and purpose of this instrument is to be construed by the Court, our heirs, executors and assigns, and all other persons whomsoever, as a present voluntary conveyance and conversion, from one to the other, and unitedly to the community of all of our earthly possessions, and each of the parties here-to do hereby grant, bargain and convey said property from one to the other, and unitedly to the community, in such form and manner that the same shall from this date be and constitute the property of the community of ourselves as husband and wife, so that we might avail ourselves of the provisions of RCW 26.16.120 concerning agreements between husband and wife, fixing the status and disposition of community property to take affect upon the death of either.

WEDEKIND surviving her, the title of and to the whole of said community property shall at once vest in the said HENRY V.
