

QUITCLAIM DEED  
UNITED STATES OF AMERICA  
TO  
STATE OF WASHINGTON

The Grantor, the UNITED STATES OF AMERICA, acting by and through the Secretary of the Army, pursuant to the authority of Section 2 of the Act of Congress approved 20 June 1938 (52 Stat. 804; 33 U.S.C. 558b), as extended by Section 3 of the Act of Congress approved 11 August 1939 (53 Stat. 1414; 33 U.S.C. 558b-1), and in performance with the provisions of Memorandum of Agreement dated 20 May 1976, between the UNITED STATES OF AMERICA, by and through the U.S. Army Engineer District, Portland, Oregon, and the STATE OF WASHINGTON, by and through the STATE DEPARTMENT OF NATURAL RESOURCES, and in consideration of the conveyance to it by the STATE OF WASHINGTON, DEPARTMENT OF NATURAL RESOURCES, of Tract 2925, Bonneville Lock and Dam, Second Powerhouse Project, hereby remises, releases, and quitclaims unto the STATE OF WASHINGTON, DEPARTMENT OF NATURAL RESOURCES all of its right, title and interest in and to the real property described in Schedule "A" attached hereto and made a part hereof.

Subject to the following exceptions and reservations:

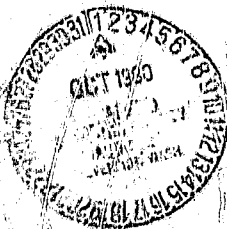
1. Reservations contained in patents from the United States of America.
2. Existing easements for public roads and highways, public utilities, railroads, and pipelines.
3. A perpetual utility easement and right-of-way in, on, over and across a 10-foot wide strip of land lying northerly of and adjacent to the northerly right-of-way line of relocated Washington State Highway 14.

TO HAVE AND TO HOLD the above described and granted premises unto said STATE OF WASHINGTON, its successors and assigns, forever.

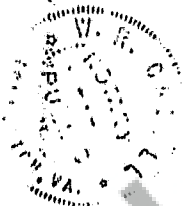

A PORTION OF TRACT 2923 AND 2924

A tract of land situated in the Southwest Quarter of Section 14, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington, being more particularly described as follows:

Commencing at a 3/4 inch iron pipe marking the quarter corner common to said Section 14 and Section 15; thence South 01°25'41" West, along said section line 1,356.47 feet; thence North 79°36'03" East 14.68 feet; thence South 88°35'26" East 139.61 feet; thence South 03°15'00" East 378 feet, more or less to the Northerly right-of-way line of the Relocated Evergreen Highway (State Highway No. 14), and the POINT OF BEGINNING;
