FEST, equally, all right, title and interest in and to the following described real estate, situate in the County of Skamania, State of Washington, together with the appurtenances thereon and all after acquired title of the grantor herein:

All that portion of Lots 5 and 12 of SEELEY'S SUB-DIVISION of the SW4 of Section 19, Township 3 North, Range 10 E.W.M., which lies easterly of the county road designated as the "Auspland Road", and

The SE4 of Section 19, Township 3 North, Range 10 E.W.M., except that portion of the N 66 ft. of the NW4 of the SE4 of said Section 19 lying northerly of the county road designated as the "Kollock Road" and except all portions of the SW4 of the SE4 lying westerly of the Auspland Road and northerly of the Cooks-Underwood Road and except all portions of the said SW4 of the SE4 lying south and west of the Cooks-Underwood Road. EXCEPTING THEREFROM, that portion of the E2 of the SE4 of said Section 19, T3N, R10 E.W.M. conveyed to William E. McAndrew by Real Estate Contract dated April 18, 1972, recorded in Book 64, Pg. 70, Deed Records of Skamania County, Washington.

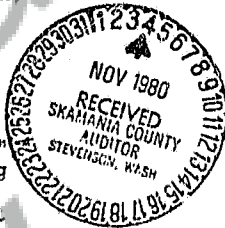

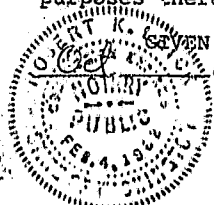
