The North Half (Ng) and the Southeast Quarter (SE4) of Section 29, Township 3 North, Range 5 E. W. M.

This conveyance is made subject to the following terms and conditions:

- I. The term "merchantable timber" as used herein shall mean all timber of every kind and specie now merchantable or becoming merchantable during the term of this conveyance.
- 2. Grantors give and grant to Grantee the right to enter the subject real property above described at any and all times during the term of this conveyance in order that Grantee, its agents, servants and contractors may have ingress and egress to said timber, and to cut and remove the same.
- 3. This conveyance shall be binding upon the parties hereto, and their respective heirs and assigns.
- 4. Grantee agrees that it shall be responsible for the determination of cutting and boundary lines, and agrees to hold Grantors free, clear and harmless from an all claims flowing from any trespass upon adjoining lands as a result of Grantee's logging operations.
- 5. Grantee covenants and agrees to promptly comply with all laws, rules and regulations of the State of Washington, its agencies, boards, and regulatory bodies with respect to the logging of the subject land and the cleaning up of said land and removal of debris following the completion of Grantee's logging of said property.
