hereby convey s and warrant s to the STATE OF WASHINGTON, the following described real estate situated in Skamania County, in the State of Washington, to the same extent and purpose as if the rights herein granted had been acquired under Eminent Domain statute of the State of Washington:

All that portion of the hereinafter described Parcel "A" lying southerly of the following described line:

Beginning at a point opposite and 30 feet northeasterly from Highway Engineer's Station (hereinafter referred to as HES) 5+16.86 P.O.T. on the centerline of SR 140, Washougal River Bridge Vicinity; thence northeasterly to a point opposite and 50 feet northeasterly from said HES 5+16.86 P.O.T.; thence easterly parallel with said centerline to a point opposite HES 5+50 on the WRR line and the end of this line description.

The grantor herein further grants to the State of Washington, or its agents, the right to enter upon the grantor's remaining lands where necessary to reconstruct said approach.


