

RESCISSION AGREEMENT

This agreement executed in triplicate this 22 day of MAY, 1981, by and between WIND RIVER MINING COMPANY, a Washington corporation, hereinafter referred to as WIND RIVER, and MILTON MITCHEK, hereinafter referred to as MITCHEK
