The SE<sup>1</sup>SE<sup>1</sup> of Section 15, T. 2 N., R. 5 E.W.M., EXCEPT a tract of land containing 0.50 acres, described as follows: beginning at the Section corner common to Sections 14, 15, 22, and 23, T. 2 N., R. 5 E.W.M.; thence North 89°39'13" West along the Section line between said Sections 15 and 22, T. 2 N., R. 5 E.W.M., a distance of 164.32 feet; thence North 05°57'13" West, a distance of 159.95 feet; thence South 71°19'43" East, a distance of 172.44 feet; thence South 41°16'13" East, a distance of 19.36 feet to a point on the Section line between Sections 15 and 14, T. 2 N., R. 5 E.W.M.; thence South 02°47'49" East, a distance of 91.36 feet to the point of beginning and containing 39.50 acres more or less, and reserving unto grantors, their heirs and assigns, and the public the right to use jointly with the State of Washington a road to be constructed by the grantee.

The Water Resources Act of 1971 specifies certain criteria regarding utilization and management of the waters of the State in the best public interest. Issuance of this certificate was based on sufficient waters available, at least during portions of the year. However, it is pointed out to the certificate holder that his use of the water may be subject to regulation at certain times, based on the necessity to maintain water quantities sufficient for preservation of the natural environment.

Diversion intake shall be tightly screened at all times with wire mesh having openings with dimensions not greater than 0.125 (1/8) inch. Water approach velocity to the screen shall be less than 1 foot per second and approaching 0.5 foot per second, as measured one foot in front of the screen.
