Declaration Of Trust**UNINCORPORATED ORGANIZATION CONTRACT****TRUST INDENTURE**

THIS TRUST ORGANIZATION CONTRACT SHALL BE OF THE TYPE KNOWN AS A PURE TRUST AND SHALL BE ADMINISTERED BY LEGAL PERSONS HOLDING TITLE AS JOINT TENANTS IN FEE SIMPLE AND NOT AS TENANTS IN COMMON, TO COLLECTIVELY ACT AS A BOARD OF TRUSTEES; ACTING UNDER A LIFE PURPOSE AND A RELIGIOUS BELIEF AS HEREIN SET FORTH, AND ACCORDING TO THE INALIENABLE COMMON LAW RIGHTS AFFORDED MAN.

DECLARATION OF AUTHORITY

This instrument shall serve as The Board of Trustees' sufficient guide, supplemented from time to time by resolutions covering contingencies as they arise and are recorded in the Minutes of its meetings. Trust Minutes are a portion of the rules and regulations of this Trust; said Minutes to be ratified always by a majority of The Board of Trustees. Such authority as awarded herein is possessed by The Board of Trustees of this Trust, thus intending only to leave open for the courts, should occasion arise, the question of conscientious dealing of those persons.

The Board of Trustees shall have all the powers necessary, convenient or appropriate to effectuate the purpose of the Trust, and shall take any action which it deems necessary or desirable and proper to carry out such purposes, provided, however, those Purposes and Actions are not inconsistent with other provisions herein. Any determination of the purposes of the Trust, made by The Board of Trustees, in good faith, shall be conclusive. In construing the provisions of this Trust Indenture Declaration and the Trust Minutes, the Presumption shall be in favor of the grant of powers to The Board of Trustees.

NAME AND DOMICILE

This Trust Organization shall be domiciled in and shall be interpreted and construed under the laws of the State of Washington or shall be changed to and interpreted under the laws of any other location as shall be deemed prudent, wise, necessary, appropriate, or desirable by the Trustees.
