**Disclaimer Deed**

WITNESSETH THIS DISCLAIMER DEED, made by Romeo B. Bonnette

1. The spouse has acquired title to the following described property situated in Skamania County, State of Wn.

Commencing at the Southeast corner of the homestead heretofore set apart by order of Court for the use of Mrs. Catherine Haffey and her minor child, and running thence East along the South line of the real estate belonging to the estate of William Haffey, deceased, 80 rods and 16 links to the Southeast corner of said real estate belonging to said estate; thence North along the East line of said real estate belonging to said estate 39 rods 9 links; thence West 20° 30' 80 rods 16 links to the East line of said homestead; thence South along the East line of said homestead 39 rods 9 links to place of beginning, containing 20 acres more or less, in Section Four (4), Township One (1) North, Range Five (5) East of the Willamette Meridian.

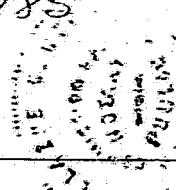
