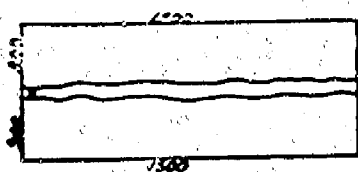


Notice of Mining Location

BOHN #6 lode, vein, ledge or deposit (or placer ground), situated in the above State, County and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel),
