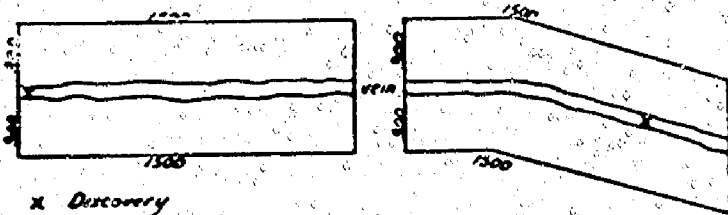


Notice of Mining Location
