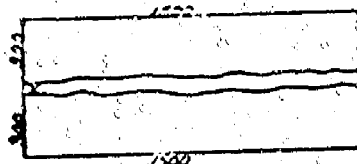


Notice of Mining Location

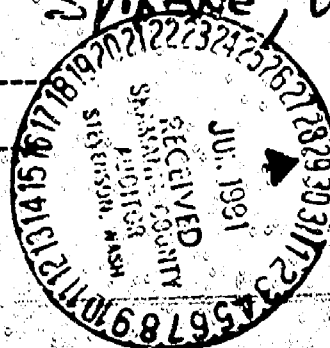
