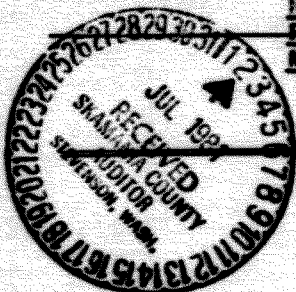

in hand paid, conveys and warrants to Ronald D. Dutson and Jellie B. Dutson, husband and wife

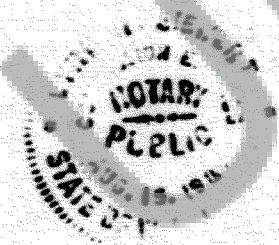
