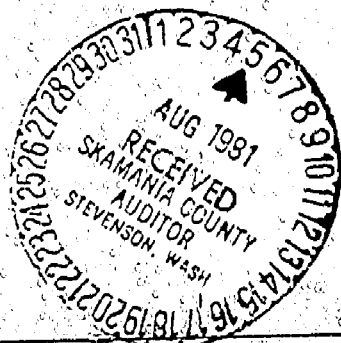

Greetings:

WHEREAS, George V. Carrier and Bonnie Jean Carrier, husband and wife Recovered Judgment against Tom Land, Jr. and Lou E.
