THAT all of said claims are contiguous and are held in common, and the work and improvements benefited and improved all of said claims.

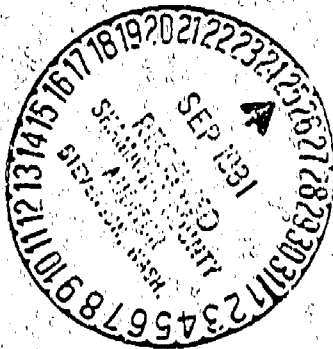
THAT the following is a description of the work and improvements made and the dates thereof:
