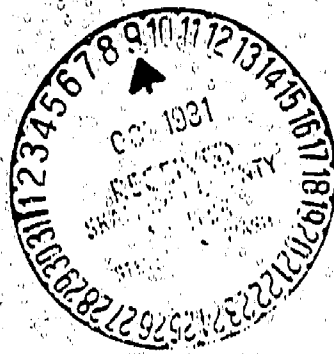


## CLAIM OF LIEN

Starting at the Northeast corner of Section 28, Township 2 North, Range 5 E.W.M., and running along Section Line South 89°03'55" West for 658.92 feet to Northeast corner of West half of Northeast quarter of Northeast quarter South 00°29'40" East for 326.37' to its intersection with the South line of the right-of-way of the Bonneville Power Administration line (B.P.A.) which is beginning of tract, running along North-South boundary of Northeast quarter, Northeast quarter Section 28, South 00°29'40" East for 578.60' to Northwest boundary of right-of-way of Labarre County Road, running along right-of-way boundary through curve 10 feet right with radius of 94.56' through central angle of 52°04'34" a distance of 85.95' running North 33°41'00" West for 74.19', running through curve to left with radius of 268.73' through angle of 63°02' for distance of 295.64', running South 83°17'00" West for 168.24' to a point, leaving right-of-way boundary and running North 00°00'00" East for 372.94' to South boundary of B.P.A.
