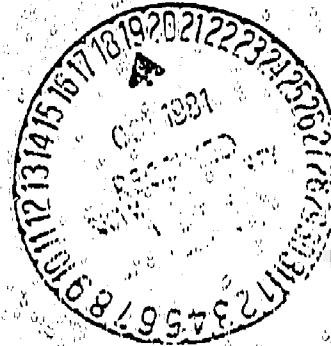

BOND
