



NOTICE IS HEREBY GIVEN that an action has been commenced in the above-entitled Court upon the complaint of the plaintiff above named against the above-named defendants; that the object of that action is to establish and quiet plaintiff's title in and to the lands and premises hereinafter described against the claim of the defendants and any of them, and to bar the defendants and each of them from having or asserting any right, title, estate, lien or interest in or to said lands and premises adverse to plaintiff's fee simple title thereto; and that the action affects title to the following described real estate situated in Skamania County, Washington, to-wit:

Auditor's File No. 83845; thence northwesterly along the southwesterly line of said Olmstead Tract, and the northwesterly extension thereof a distance of 302 ft.; thence northeasterly parallel with the southeasterly line of said Olmstead Tract to the point of beginning.

Tract 2: A tract of land located in the Felix G. Iman D.L.C. in Section 2, Township 2 North, Range 7 E.W.M. described as follows:

Beginning at the northwest corner of the Daniel Baughman D.L.C.; thence North 358.25 ft.; thence North 61° 09' West 430.30 ft.; thence North 50° West 76.80 ft.; thence South 50° West 30 ft.; thence North 50° West 132 ft. to the initial point of the tract hereby described; thence South 50° West 460.38 ft.; thence South 73° 56' East 72.19 ft.; thence North 40° East 431.11 ft.; thence North 50° West 66 ft. to the initial point; said tract containing .6 acres more or less.
