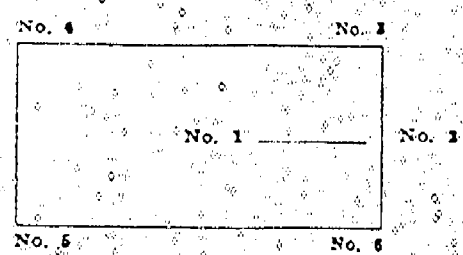

NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and does hereby locate 1500 linear feet in length, and 600 feet in width on the W.R./W.M.R. #8

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District and further described as follows: Commencing at a post marked No. 1 at the Discovery Shaft (cut or tunnel), from thence 1500 feet in a ENE direction to an end post marked No. 2, thence 600 feet in a NNW direction to a corner post marked No. 3, thence 1500 feet in a WSW direction to a corner post marked No. 4, thence 600 feet in a SSE direction to a corner post marked No. 1 at the point of Beginning, direction to a corner post marked No. 6, thence feet in a direction to said end post No. 2, hereby locating and intending to claim feet in a direction from discovery to the end line, and feet in the opposite direction from discovery to the

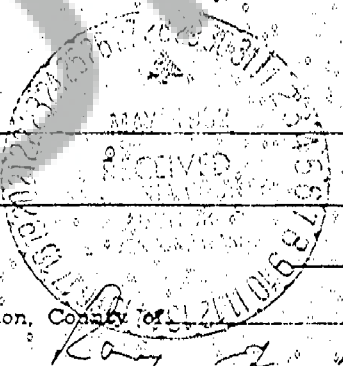
end line, and feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
