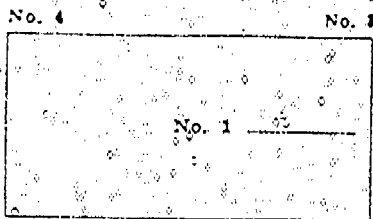

This diagram explains method of description of claim

NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length, and 600 feet in width on the W.R./W.M.R. 66

lode, vein, ledge or deposit (or placer ground), situated in above State, County of Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery Shaft (cut or tunnel), from thence

600 feet in a N.W.

direction to an end post marked No. 2, thence 1500 feet in a E.N.E.

direction to a corner post marked No. 3, thence 600 feet in a S.S.E.

direction to a corner post marked No. 4, thence 1500 feet in a W.S.W.

direction to a corner post marked No. 5, thence 600 feet in a N.W.

direction to a corner post marked No. 6, thence 1500 feet in a E.N.E.

direction to said end post No. 2, hereby locating and intending to claim

600 feet in a direction from discovery to the end line, and

1500 feet in the opposite direction from discovery to the end line, and

600 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. This claim is further described as follows:

Discovery located 5800 S.E. of the NE corner of SEC. 28, T.6N. R.7E. Williams Co. Meridian Wind River Road. Discovery is further located 9600 E.N.E. to Rock Point. Discovery is a common corner to W.R./W.M.R. 66 S. 65° 47' E. 1500
