2. Description of Evidence Found:

Orig. 40" now 48" D-Fir stump N19W, 70' burned blaze obvious (record N25W).

Orig. 30" now 40" D-Fir stump S2E, 48.0' axe marks on felled rotted log down slope from stump. (record S8E-70 lks.).

Orig. 36" now 40" D-Fir stump S12W, 50.5' marks on down log rotted away (record S8055'W-75 lks.).

Set 2 1/2"x30" Gal. steel pipe with a 2 1/2" Brass cap in a mound of stone. Marked:

18" D-Fir N57W, 13.7 ft. scribed T4NR/ES4 upper blaze and a lower blaze scribed BT and with a

3/4" Brass disk stamped PLS 16337.

10" D-Fir N21E, 38.7 ft. scribed T4NR/ES3 upper blaze and a lower blaze scribed BT and with a

3/4" Brass disk stamped PLS 16337.

10" D-Fir S19E, 25.7 ft. scribed T4NR/ES10 upper blaze and a lower blaze scribed BT and with a

3/4" Brass disk stamped PLS 16337.

20" D-Fir S15W, 25.5 ft. scribed T4NR/ES9 upper blaze and a lower blaze scribed BT and with a

3/4" Brass disk stamped PLS 16337.

Set guard post East with sign 54-4 only.

Nailed BT and 54-4 signs to all BT's and painted band and blazes red.
