This corner was originally set by Deputy Lewis D.W. Shelton in July 1899, & Oct.-Dec. 1900 under Contract No. 552. Remonumented by Floyd A. Brooks, Cadastral Surveyor in Oct. & Nov. 1961.

B.L.M. Brass cap on concrete post.

Orig. 10" now 24" D-Fir stump N49E, 49 lks. healed blaze.

Orig. 10" now broken 20" D-Fir stub S68E, 25 lks. face chopped out.

Orig. 8" now 20" D-Fir uproot N33W, 12 1/2 lks. blaze healed.

Brooks 8" now 10" Hemlock S59E-25 lks. scribing visible.

Brooks 8" now 9" Hemlock S+W-147 1/2 lks. scribing visible (snag).

Unrecorded 14" Fir N13W, 3 ft. healed blaze.

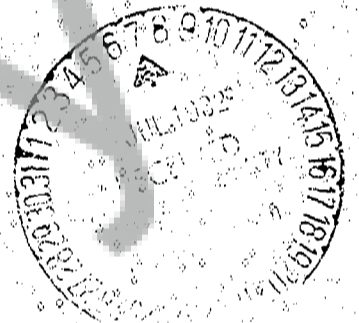
#### New Bearing Trees:

7" Hemlock N23E, 24.1 ft. scribed TNR6ES23 upper blaze and a lower blaze scribed BT and with a 3/4" Brass disk stamped PLS 16337.

8" Alder S73W, 23.6 ft. bark scribed TNR6ES24 BT and with a 3/4" Brass disk stamped PLS 16338.

Nailed 54-4 and BT signs to all BT's and painted band and blazes red.

Set guard posts North-South-East & West with sign 54-4 and BM 102 decal.
