This corner was originally set by Deputy Lewis D.W. Shelton in July 1899, & Oct.-Dec. 1900 under Contract No. 552. Remonumented by Floyd A. Brooks, Cadastral Surveyor in Oct. & Nov. 1961.

Corner destroyed by fire trail construction.

Orig. 10" Wh. Fir now 28" Hemlock snag 12 ft. tall-healed blaze, N38 $\frac{1}{2}$ W-41 lks..

Orig. 36" now 20" Wh. Fir rotted stump S70E-12 lks.-no marks remaining.

Brooks 20" now 22" Hemlock S55E-21 $\frac{1}{2}$ lks. scribing visible on partially healed blaze.
