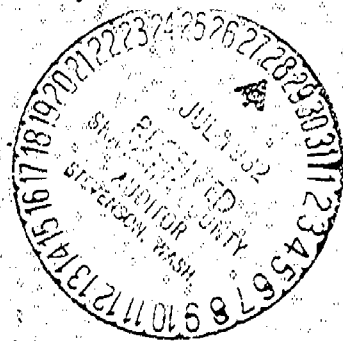

were so performed and rendered upon said logs between the
11th day of May, 1982, and the 12th day of July, 1982; and
